Further it was decided to re allot 10 marks assigned to interview to the academic score. In this context the Board resolved to constitute a Sub Committee with the following Hon'ble Members of Board of Management to frame guidelines for direct recruitment of teaching and non teaching posts.

**Item No.03 Absorption of Assistant Professor (OPG) at KVAFSU, Bidar**

**Resolution**

The Registrar presented the item by narrating correspondence between the University and Government, opinion of the Academic Council and proceedings of 89<sup>th</sup> & 91<sup>st</sup> Meeting of Board of Management. Sri.K.C.Shankaregowda Hon'ble Board Member informed that Government communicated the University number of times with respect to absorption of Assistant Professor (OPG) at KVAFSU, Bidar. He stated that Sri.Manjunath Naik, the then Secretary to Govt. Animal Husbandry & Fisheries Department directed the University to send a proposal for amendment of Act and Statutes of the University for absorption of Veterinary Officer on deputation. Sri.Iresh Anchatageri Hon'ble Board Member informed that Board is not having power for amendment of Act & Statutes of the University. Further, he stated that

absorption of Assistant Professor (OPG) may lead to roster problem, if some Hyderabad Karnataka candidate goes to court may create legal problem. Sri.K.C.Shankaregowda and Sri.Harsha, Hon'ble Board Members opined that as per the cabinet note University has to make a provision and send a proposal for amendment to the Act & Statutes of the University for 22 Assistant Professors (OPG) and 8 Assistant Professor (OPG) who are working at IAH&VB. Dr.K.Venkata Reddy and Sri.Mukund Varma opined that the Assistant Professor (OPG) are working in the University for more than seven years which helped the veterinary colleges to over come the shortage of manpower and helped for VCI recognition. The Secretary, AHF opined that roster may come in the way for absorption, if such is the case whole exercise will be futile. Further he informed to submit the proposal to the Government for further needful.

On detailed discussion and deliberation it was resolved to submit a proposal to the Government within 10-15 days to make provision for amendment of Act and Statutes of University for absorption of 22 Veterinary Officers from Department of AH &VS, Govt. of Karnataka who are on deputation to KVAFSU as Assistant Professor (OPG) and 8 Veterinary Officers from Dept. of AH &VS who are working in IAH&VB on deputation.

Further, it was decided to reimburse the scholarship for SC/ST students from University from internal resources, even if there is an a delay in release of amount from Social Welfare Department.

**8. Complaint against Sri.K.L.Suresh, Retd Comptroller and others of KVAFSU, Bidar:**

Sri.K.C.Shankaregowda and Sri.K.Venkata Reddy, Hon'ble Board Members informed that Sri.K.L.Suresh, Retired Comptroller, KVFSU, Bidar has created duplicate bills and made payments for more than 53 agencies which are seems to be bogus. Further, they informed that one of such agency i.e. Shruthi Enterprises transferred amount through NEFT/Cheque as an a kick back to the following members of Sri.K.L.Suresh Family and contractual staff :

1. Sri.K.L.Suresh, Retired Comptroller, KVAFSU, Bidar
2. Sri.K.S.Rakesh S/o Sri.K.L.Suresh
3. Sri.K.L.Suresh own brother Sri.Basawaraj.K.L
4. Sri.Gundakppa Sadu, Assistant (Contract Basis) Comptroller's Office, KVAFSU, Bidar
5. Smt.Shobarani W/o Gundappa Sadu
6. Sri.Sunil Kumar Patil, Assistant (Contract Basis), Comptroller's Office, KVAFSU, Bidar
7. Sri.Nagshetty, Assistant (Contract Basis), Comptroller's Office, KVAFSU, Bidar
8. Sri.Shivakumar, Attender (Contract Basis), Comptroller's Office, KVAFSU, Bidar
9. Sri.Sundaram

Further, they also stated that one more agency i.e. Pooja Enterprises for which one of the contractual employee Mr.Akash S/o Vijaykumar is a owner of said enterprise. To this firm lakhs of rupees has been transferred from University account. Similarly one more agency i.e. Vaishnavi Enterprises received lakhs of rupees from the University. This agency transferred an amount to personal account of Mr.Mritunjaya who is working as Senior Assistant at Comptroller's Office, KVAFSU, Bidar. Sri.Iresh B Anchatageri, Hon'ble Board Member opined that committee can be constituted to enquire into the allegations. Further, he stated that there should be a documentary proof to handover the case to Anti Corruption Beauru (ACB). The Secretary, AHF opined it can be given to the Anti Corruption Beauru, but these allegations are not come in the audit report and there should be a documentary evidence to say that they are bogus agencies. In this context our intension should be to take the University in right path. Further, he stated that enquiry can be conducted

on one agency i.e. Shruthi Enterprises is suppliers of materials to University. The University staff and their relative received money through account transfer from the agency. We are having doubt that this may be kick back. He also informed that usually University make payments to number of firms for the material supplied. Hence it has to be ascertained yourselves with Comptroller with respect to allegations made, prima face of case has to be established. He also mentioned that enquiry can be taken up with respect to kick back received from Shruti & Pooja enterprises by Sri.K.L.Suresh, his relatives & staff of Comptroller's office of KVAFSU, Bidar. He also posed a question weather any documentary evidence is there for all the 53 companies on which allegations are made? Dr.K.Venkata Reddy informed that there is no proof for all the 53 companies. Sri.K.C.Shankaregowda informed that more than 6.00 crores has been deposited to various agencies from University. Further, he stated that there is a doubt on Genuinity of these companies. However, if we enquire on any two companies the information may come out for rest of the agencies also.

On detailed discussion and deliberation the Board resolved to take a written complaint from Sri.K.C.Shankaregowda & Dr.K.Venkata Reddy on their letter head. On the basis of the written complaint with an documentary evidence and after ascertaining the primface the enquiry can be assigned to ACB with respect to kick back received from .Shruthi, Pooja Enterprises and such other agencies by Sri.K.L.Suresh, his relatives and staff of Comptroller's Office and their genuinity.

2. Registered companies only can participate in the tender
3. Duration of tender should be two years.

**5. Tender Accepting Committee**


On detailed discussion Board of Management resolved that Finance Committee will be the Tender Accepting for accepting the tender.
