Online applications in the prescribed proforma are invited from the eligible Foreign Nationals (FN)/ Non-Resident Indian (NRI) or Overseas Citizen Certificate (OCI) or Person of Indian Origin (PIO)/ Non-Resident Indian Children (NRI's-C)/Non-Resident Indian Sponsored Candidates (NRI-S) for admission to B.V.Sc. & A.H., B.Tech (D.Tech) & B.F.Sc., degree programmes at KVAFSU, Bidar for the academic year: 2023-2024.

Candidate who desirous to apply for multiple degree programmes must submit separate applications along with prescribed fee payable in Indian Rupees 10,000/- only, for each of the degree programme.

**Eligibility and Selection criteria of B.V.Sc. & A. H., degree programme:**

1. The eligibility for the seats under for B.V.Sc. & A.H. Degree Programme remains same as per the Academic Information Regulation Governing B.V.Sc. & A.H. Degree Programme under MSVE 2016 of Veterinary Council of India, where in candidate must have passed 12th Standard/PUC or its equivalent as a qualifying examination comprising the subjects of Physics, Chemistry, Biology/ Biotechnology and English with a minimum score of 50% aggregate marks in Physics, Chemistry, Biology/ Biotechnology and English.
2. Admission of candidates to B.V.Sc. & A.H. degree programme under the **FN category** shall be based on the merit scored in 12<sup>th</sup> Standard/PUC or its equivalent qualifying examination comprising the subjects of Physics, Chemistry, Biology (Botany & Zoology)/Biotechnology and English.
3. Admission to B.V.Sc. & A.H. degree programme under the **NRI, OCI, NRI's-C category** shall be based on the merit of **NEET-2023 Score** (entrance examination conducted by the National Testing Agency).
4. The selection for seats under NRI-S (Karnataka Domiciles only) for B.V.Sc. & A.H. Degree Programme shall be based on the **K-CET Veterinary ranking 2023** conducted by the Karnataka Examination Authority (KEA), Bengaluru. Whereas, selection for seats under **NRI-S (All India)** shall be based on the **NEET ranking 2023** conducted by the National Testing Agency. Karnataka Domiciles candidates who have not appeared for K-CET can opt for seat under NRI-S (All India) based upon NEET ranking and if such candidate is admitted, they have to pay fees prescribed for NRI-S (All India) category.

**Eligibility and Selection criteria of B.Tech (D.Tech) & B.F.Sc., degree programme:**

1. Candidate must have passed 12th Standard/PUC or its equivalent as a qualifying examination comprising the subjects of Physics, Chemistry, Mathematics, Biology (Botany & Zoology) and English.
2. Admission of candidates to B.Tech (D.Tech) and B.F.Sc., degree programme under the **FN, NRI, OCI/PIO, NRI's-C category** shall be based on the merit scored in 12<sup>th</sup> Standard/PUC or its equivalent qualifying examination comprising the subjects of Physics, Chemistry, Biology (Botany & Zoology) and Mathematics with medium of instruction in English language.
3. The selection of the seats under NRI-S (Karnataka Domiciles only) for B.Tech (D.Tech) and B.F.Sc., Degree Programme shall be based on the **K-CET Agriculture ranking- 2023** conducted by the Karnataka Examination Authority (KEA), Bengaluru. Whereas, selection for seats under NRI-S (All India) shall be based on the on the average marks scored in Physics, Chemistry, Mathematics and Biology in 12th Standard/ PUC, or its equivalent examination. Karnataka Domiciles candidates who have not appeared for K-CET may opt for seat under NRI-S (All India) based upon the merit scored in 12<sup>th</sup> Standard/PUC or its equivalent qualifying examination comprising the subjects of Physics, Chemistry, Biology (Botany & Zoology)/Mathematics with medium of instruction in English language and in case if such candidate is admitted, they have to pay fees prescribed for NRI-S (All India) category.

**GUIDELINES AND INSTRUCTIONS FOR ADMISSION TO B.V.Sc. & A.H., B.Tech (D.Tech) AND B.F.Sc., DEGREE PROGRAMMES UNDER FOREIGN NATIONALS / NON-RESIDENT INDIAN OR OVERSEAS CITIZEN CERTIFICATE (OCI) OR PERSON OF INDIAN ORIGIN (PIO) / NON RESIDENT INDIAN CHILDREN /NON-RESIDENT INDIAN SPONSORED CANDIDATES AT KVAFSU, BIDAR FOR THE ACADEMIC YEAR: 2023-24**

**General Information to the Applicants:**

1. The applicants/candidates should have attained the age of **17 Years** and should not have completed **25 years** of age as of **31.12. 2023**. No relaxation of the minimum and maximum age limit is permissible on any grounds whatsoever.
2. The admission shall be based on the merit secured in Qualifying Examination *i.e.*, 12th Standard/ Pre-University Course (PUC), or its equivalent examination (on regular mode) and/or the entrance examination prescribed for admission to a particular degree programme.
3. If a candidate has not received the original marks card of Qualifying Examination for the Academic Year **2023** from the concerned Institutions/boards, then the candidate should obtain the signature of the Principal of the institution where candidate has passed 2nd PUC/12th Standard examination on the provisional marks card. *Internet downloaded marks statement printouts are not acceptable.*
4. In case of foreign national applicants/candidates, if the qualifying examination is other than 10+2 or 12<sup>th</sup> Standard of India, then the certificates/ transcripts of equivalent qualifying examination (10+2 or 12<sup>th</sup> Standard) must have been recognized and approved by the Association of Indian Universities (AIU). Candidates must submit an EQUIVALENCE CERTIFICATE issued by the AIU. Candidates may refer to the Website of AIU for more information about the Application procedure for obtaining Equivalence Certificate.
5. Applications submitted, which are in proper order shall be accepted and mandated till finalization of the programme applied for. The category once filled in the application form shall be final and cannot be changed at later stage.
6. The candidates must ensure that duly completed Application along with relevant documents must be uploaded ONLINE on or before **30.09.2023(IST 23:59:59 Midnight)**. Applications without the relevant documents shall be summarily rejected.
7. The hard copy of the original application uploaded online and relevant original documents must be submitted at the time of offline counseling for verification (after online submission, the original application along with relevant documents uploaded must be downloaded and printed).
8. If any of the information provided in the application or documents submitted is found false either during counseling or after admission or at any point of the degree programme admitted, such candidates will be debarred from the admitted course or legal action will be initiated. In such cases the entire amount of Course fee/Institutional economic fee/ other regular fees paid shall be forfeited.
9. Economic fees, admission fees, tuition fee, any other fees and charges will be applicable as per instructions issued by the University from time -to time.
10. Online notification of the candidate's eligibility for offline counseling or the candidates merely attending the offline counseling process shall not confirm their right for admission to the course applied for at KVAFSU, Bidar.
11. The decision to fill or not to fill and modalities to fill the seats remaining vacant due to non-availability of eligible candidates by FN, NRI, OCI,POI, NRI's-C and NRI-S shall rest with the university.

12. In the event of student discontinuing or cancelling his admission in the middle of degree programme, the student has to pay the processing fees as stipulated by the University for discontinuing or cancelling his admission.
13. **DISCLAIMER:** The statements made and information contained in the Notification / Prospectus is of general nature for the knowledge of the candidate seeking admission to various programmes of the university constituent and affiliated colleges. The information contained herein is believed to be correct at the time of publication/uploading. **Meaning of Terminologies for admission process at KVAFSU, Bidar:**

**I. FOREIGN NATIONAL (FN)/ INTERNATIONAL:**

The Applicants/Students holding passports issued by foreign countries including people of Indian origin who have acquired the nationality of foreign countries and studied abroad, but not appeared for NEET examination are considered as foreign national applicants/students.

**Note:** Applicants/Students holding passports issued by foreign countries and have studied in India, if found eligible shall be considered on par with NRI, OCI, PIO for allotment of seat based upon NEET 2023 ranking. Therefore it is mandatory for such students to appear NEET 2023 conducted by National Testing Agency.

**II. NON-RESIDENT INDIAN:**

In the case of the general public, an individual being Indian citizen or person of Indian origin is said to be Non Resident Indian(NRI) in any financial year, if candidate satisfies both the following conditions: Candidate resides in India for less than one hundred and eighty-two days (182) during the previous financial year or who stays outside India for employment or for carrying on business or vocation outside India, or who stays outside India for any other purpose indicating his intention to stay outside India for an uncertain period. An Indian Citizen stay in India for less than 365 days during the four preceding previous financial years and less than 60 days in that that financial year.

**III. NON-RESIDENT INDIAN (NRI) STUDENTS:**

- a. Non-Resident Indian students are Indian Nationals studied abroad. They must have had at least 3 (three) years of education in any foreign country during the last 6 (six) years and must have passed the qualifying examination (12th standard or equivalent) from abroad only and in the college/ institutes affiliated to Boards of Secondary Education or Universities located in India.
- b. This includes the Indian students studying in the schools or colleges situated in foreign countries even if they are affiliated to Boards of Secondary Education or Universities located in India, but will not include students studying in those schools or colleges (situated in India) and affiliated to the Boards of Secondary Education or Universities of the foreign countries.
- c. In case an intervening period/gap is involved, a certificate/affidavit from a Class-I Gazetted Officer/Notary Public for the entire intervening period/gap showing the candidate's

preoccupation after leaving the Institution last attended shall be produced by such applicants.

#### **IV. OCI/POI CARDHOLDERS**

The Ministry of Home Affairs vide Notification dated 4th March 2021 specified the rights to which an OCI/POI cardholder shall be entitled under the Citizenship Act, 1955. Clause (4) (ii) of the said Notification reads as under: “(4) parity with Non-Resident Indians in the matter of, (ii) appearing for the all India entrance tests such as National Eligibility cum Entrance Test, Joint Entrance Examination (Mains), Joint Entrance Examination (Advanced) or such other tests to make them eligible for admission only against any Non-Resident Indian seat or any supernumerary seat:

Provided that the OCI/POI cardholder shall not be eligible for admission against any seat reserved exclusively for Indian citizens.

The above Notification provides the following Explanation: “The OCI Cardholder (including a PIO card holder) is a foreign national holding passport of a foreign country and is not a citizen of India.” Similarly, the PIO cardholder and foreign nationals shall not be eligible for admission against any seat reserved exclusively for Indian citizens.

#### **V. NON-RESIDENT INDIAN’S CHILDREN (NRI’S-C):**

- a. Children of NRI parents/guardians are those who have at least one of their parents/guardians residing abroad as an NRI. In case of no parents, the guardian must be an NRI residing abroad and must regard the applicant as his/her ward, as evidenced by an affidavit demonstrating interest in the student's affairs.

#### **VI. NRI SPONSORED STUDENTS (NRI-S):**

- a) The Sponsor financing the education of a student must be an NRI and/or blood relation such as spouse, children (natural/adopted/foster), siblings, paternal uncle/aunt, maternal uncle/aunt, paternal grandfather/grandmother, and maternal grandfather/grandmother, paternal and maternal cousins.
- b) The Sponsor possessing a student / visiting visa or temporary visa of any nature from other countries is not eligible to sponsor. The Sponsor must produce the proof of the annual income sufficient to support the course of study of his/her ward.

#### **VII. KARNATAKA DOMICILE:**

Eligibility for Karnataka domicile is determined based on fulfillment of one of the following criteria:

- a. The candidate should have studied and passed in one or more Government or Government recognized educational institutions located in the State of Karnataka for a minimum period of SEVEN academic years commencing from 1st standard to 2nd PUC / 12th standard as on 1<sup>st</sup> July 2023, in which the CET is held and must have appeared and passed either SSLC/10th standard or 2nd PUC/12th standard examination from Karnataka State. In case of the candidate who had taken more than one year to pass a class or standard, the years of academic study is counted as one year only.
- b. The candidate should have studied and passed either 1<sup>st</sup> and 2<sup>nd</sup> Year Pre-University Examination or 11<sup>th</sup> and 12<sup>th</sup> standard examination within the State of Karnataka from an Educational Institution run or recognized by the State Government and that either of the parents should have studied in Karnataka for a minimum period of SEVEN years.

### **Eligibility Criteria and Admission Process:**

1. The eligibility for the seats under for B.V.Sc. & A.H. Degree Programme remains same as per the Academic Information Regulation Governing B.V.Sc. & A.H. Degree Programme under MSVE 2016 of Veterinary Council of India, where in candidate must have passed 12th Standard/PUC or its equivalent as a qualifying examination comprising the subjects of Physics, Chemistry, Biology/ Biotechnology and English with a minimum score of 50% aggregate marks in Physics, Chemistry, Biology/ Biotechnology and English.
2. Admission of candidates to B.V.Sc. & A.H. degree programme under the FN category shall be based on the merit scored in 12th Standard/PUC or its equivalent qualifying examination comprising the subjects of Physics, Chemistry, Biology (Botany & Zoology)/Biotechnology and English.
3. Admission to B.V.Sc. & A.H. degree programme under the **NRI, OCI, NRI's-C category** shall be based on the merit of **NEET-2023 Score** (entrance examination conducted by the National Testing Agency).
4. The selection for seats under NRI-S (Karnataka Domiciles only) for B.V.Sc. & A.H. Degree Programme shall be based on the **K-CET Veterinary ranking 2023** conducted by the Karnataka Examination Authority (KEA), Bengaluru. Whereas, selection for seats under NRI-S (All India) shall be based on the **NEET ranking 2023** conducted by the National Testing Agency. Karnataka Domiciles candidates who have not appeared for K-CET can opt for seat under NRI-S (All India) based upon **NEET ranking** and if such candidate is admitted, they have to pay fees prescribed for NRI-S (All India) category.
5. Candidate must have passed 12<sup>th</sup> Standard/PUC or its equivalent as a qualifying examination comprising the subjects of Physics, Chemistry, Mathematics, Biology (Botany & Zoology) and English for B.Tech (D.Tech) and B.F.Sc., degree programme.
6. Admission of candidates to B.Tech (D.Tech) and B.F.Sc., degree programme under the **FN, NRI, OCI/PIO, NRI's-C category** shall be based on the merit scored in 12<sup>th</sup> Standard/PUC or its equivalent qualifying examination comprising the subjects of Physics, Chemistry, Biology (Botany & Zoology) and Mathematics with medium of instruction in English language.
7. The selection of the seats under NRI-S (Karnataka Domiciles only) for B.Tech (D.Tech) and B.F.Sc., Degree Programme shall be based on the **K-CET Agriculture ranking- 2023** conducted by the Karnataka Examination Authority (KEA), Bengaluru. Whereas, selection for seats under NRI-S (All India) shall be based on the on the average marks scored in Physics, Chemistry, Mathematics and Biology in 12<sup>th</sup> Standard/ PUC, or its equivalent examination. Karnataka Domiciles candidates who have not appeared for K-CET may opt for seat under NRI-S (All India) based upon the merit scored in 12<sup>th</sup> Standard/PUC or its equivalent qualifying examination comprising the subjects of Physics, Chemistry, Biology (Botany & Zoology) and Mathematics and in case if such candidate is admitted, they to pay fees prescribed for NRI-S (All India) category.
8. Candidates applying under NRI, NRI's-C, NRI-S category should submit the recent NRI Status Certificate of the Candidate/Parents/Sponsorer, respectively, issued by the Indian Embassy of the Country concerned with their seal as per **ANNEXURE-I** or **ANNEXURE-III**, as applicable.
9. Parents/Guardians who are Overseas Citizen of India (OCI)/ Person of Indian Origin (PIO), who is holding a foreign passport, shall be treated on parity with NRI. Necessary proof should be submitted along with the application as per **ANNEXURE-II**
10. The successful candidates shall be **admitted in the order of preference**: Foreign Nationals (FN)/ Non-Resident Indian (NRI) or Overseas Citizen of India (OCI) or Person of Indian

Origin (PIO)/Non-Resident Indian's Children (NRI's-C)/ NRI Sponsored (Karnataka Domicile only), respectively. Further, subject to availability of vacant seats if any such seats shall be filled under NRI Sponsored (All India).

11. Depending on the availability of seats, the successful candidates may exercise their option for the college at the time of counseling -cum admission. Allocation of the colleges shall be in the order of **FN, NRI or OCI or PIO, NRI's-C, NRI-S**, based on the merit.
12. The candidates called for counseling must come prepared to pay the Institutional Economic Fee and other regular fees online (RTGS / Net Banking) and must remit such fees at the time admission. In case of failure to remit the prescribed fees at the time admission such candidates shall forfeit their opportunity for admission, and such seat shall be allotted to the next candidate in the merit list.
13. All types of Fees must be paid in Indian Rupees only. Foreign currencies either in the form of currency notes/cheques are not acceptable.
14. Upon securing admission, candidates/students must pay the requisite fees for their admission category throughout the programme, even if their status changes for example NRI- to Non-NRI, FN to Indian citizen or OCI to Indian citizen.
15. After scrutiny of the applications/successful completion of the counseling process, the University shall issue a 'Provisional Admission Letter' to eligible candidates for the purpose of obtaining a 'Student Visa' from the Indian Consulate/Embassy.
16. All international students will require a 'Student VISA' endorsed to Karnataka Veterinary, Animal and Fisheries Sciences University (KVAFSU), Bidar for joining full-time courses.
17. Admission of FN, NRI, OCI/PIO, NRI's-C and /NRI-S students will be confirmed ONLY after verification of all the relevant original certificates/testimonials, and payment of the required fee and other such requirements, if any, shall be determined by the university from time to time.
18. The FN, NRI, OCI/PIO, NRI's-C, NRI-S students must abide by the Academic Regulations of KVAFSU, Bidar and the code of conduct as applicable to Indian students enrolled for the degree programme from time -to time.
19. For documents other than English, one must submit English translations of all such documents/transcripts, duly attested by the concerned / accredited by the competent authority and duly certified by the Indian Embassy or Consulate.
20. Upon arrival in India, every Foreign student must register with the Foreigners Regional Registration Officer (FRRO), Bengaluru within 14 days from the date of first entry into India as per the prescribed applicable procedure and document proof shall be submitted to the University.
21. Upon securing provisional admission at KVAFSU, Bidar the concerned Foreign/ International students must submit their Student VISA endorsed to KVAFSU, Bidar within one month of completion of admission formalities, failing which their admission shall stand cancelled.
22. Foreign/International students admitted shall maintain their status of Student VISA throughout the course and students must not change the type of VISA during the study period at KVAFSU, Bidar.
23. The International/ Foreign students seeking admission must have a valid student VISA, declared medically fit after examination by the Medical Officer authorized by the Indian Embassy in the home country of the student and they must have full cover of medical insurance for entire period of study/stay in India.
